Dear Mr. Speaker, Senator McConnell, Ms. Pelosi, and Senator Reid:

The Association of the United States Army (AUSA) urges you to work together to avoid an extended continuing resolution (CR) or a government shutdown in Fiscal Year 2016 (FY16).

During the first part of this year, there was reason for optimism that Congress would return to regular order and pass the authorization and appropriations bills on time. However, I note with disappointment that once again an impasse has been reached over FY16 funding levels. Members of Congress have increasingly alluded to the possibility of an extended, or even a year-long, CR.

As you know, an extended CR would be extremely detrimental to our Army, our national security and our economy. The inefficiency created by a CR wastes significant amounts of taxpayer money. Further, a long-term CR increases the risk to our soldiers because it reduces our Army's flexibility to respond to pressing operational needs. Finally, it reduces American global stature when we repeatedly demonstrate governmental dysfunction instead of regular order.

Our country needs to avoid a government shutdown with a short CR, followed immediately by a multi-year budget deal that will create stability and efficiency in our spending. I implore you to begin negotiations now and find a budget compromise that both chambers of Congress can pass and the President will sign into law.

Thank you for your service to our country and your attention to this letter.
