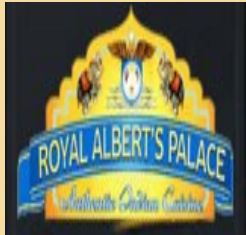

SSG Earl Granville USA Ret. served as a combat infantryman with the Pennsylvania Army National Guard in both Iraq and Afghanistan. In the summer of 2008 while on a patrol in Zornat, Afghanistan, a roadside bomb hit his vehicle. This resulted in the amputation of his left leg through the knee. As part of his rehabilitation he found himself competing in many sports as an adaptive athlete such as Mono-ski, Sled Hockey, GoRuck endurance Challenges and Spartan Races. SSG Granville is now an advocate for disabled veterans and speaks publicly about the importance of finding help in battling mental adversity.
